Pension agreement. More questions than answers



You will already have heard the news in the media. On Tuesday June 4th, the government and the social partners reached an agreement in principle on the future pension system. The left of center opposition parties GroenLinks and PvdA also support this agreement. The members of the trade unions expressed their views on the agreement in an advisory referendum. The majority voted in favor.

You will receive your UPS in your digital mailbox in "<u>My PDN pension</u>" or on paper at your home address if you have indicated that you do not want to use PDN digital mail. As we cannot send out all the UPSs at once, we are starting with the pensioners. We will be sending out UPSs until the end of September.

PDN Invests in Green Projects of the Dutch Government and the EBRD



By investing in green projects of the Dutch government and the European Bank for Reconstruction and Development (EBRD), PDN is taking steps in terms of sustainability.

Green Bond Dutch government

PDN has invested 36 million euros in a "Green Bond" issued by the Dutch government. This makes PDN one of the largest investors, relatively speaking, in this first Green Bond issued by the Dutch government. It also puts the Netherlands as the first country with the highest credit rating (AAA) to issue a green bond. The funds raised from this bond are used to finance measures and projects that reduce CO_2 emissions and help achieve the government's climate objectives.

We sent out a member survey to all members who accrue pension at and receive pension from PDN and asked them whether they'd like to give us their opinion. Have you voted yet?



We've already received piles of ballots. If you accrue pension at or receive pension from PDN and have not yet voted, now is the time to elect your representative in the Accountability Council (AC) and cast your vote. This is important: your vote determines who represents you in the AC.

There are elections for the representatives for employees and for pensioners. If you are eligible to vote, you will have received the election paper and a ballot paper at your home address.

All ballots must be received by PDN by June 28 at the latest. All votes will be counted on July 2. Shortly after that, we'll announce the new representatives for the AC.

We'll keep you informed.
